I hereby waive any and all claims, actions, causes of action, demands, costs, loss of service claims, expenses, and loss of compensation claims, whatsoever, which the undersigned may hereafter accrue on account of, or in any way growing out of any and all known and unknown, foreseen and unforeseeable bodily injuries, property damage, and consequences thereof resulting from any instruction, training, or any athletic contest or events associated with this class, including travel to and from class, or contest or activities, and hereby assume all risks incident thereto.**
